

# MEDIEVAL TESTIMONIES OF CLERGY ORDAINED IN THE ARCHDIOCESE OF GNIEZNO (POLAND)<sup>1</sup>

The archival documents documenting the activities of the Church in medieval Poland, do not hold separate *libri formatarum*, while original testimonies of ordained clergy are scarce. Copies of such testimonies were usually entered in the bishop's records or the consistory books of the respective dioceses. Research carried out in archives and libraries has resulted in identifying numerous *litterae formatae* of Polish clergy from the 15<sup>th</sup> and the first half of the 16<sup>th</sup> century, including testimonies of ordaining 29 clergymen from the Gniezno archdiocese. An analysis of their contents has confirmed some of the opinions in literature on the subject on ordaining Polish clergy in the late Middle Ages. As a result, corrections and additions have been made to the previous findings relating to the medieval calendar of clergy ordinations and their geographic distribution in the former archdiocese of Gniezno. The editing of these testimonies has shed new light on the prosopographical research into Polish clergy in the 15<sup>th</sup> – 16<sup>th</sup> centuries.

Archívne dokumenty dokumentujúce činnosť cirkevi v stredovekom Poľsku neobsahujú samostatné *libri formatarum*. Pôvodné svedectvá o ordinovaní duchovných sú vzácne. Kópie takýchto svedectiev sa zvyčajne zapisovali do biskupských záznamov alebo do konzistoriálnych kníh príslušných diecéz. Výskum realizovaný v archívoch a knižničiach viedol k identifikácii početných *litterae formatae* poľských duchovných z 15. a prvej polovice 16. storočia, vrátane svedectiev o vysvätení 29 klerikov z hniezdenkej arcidiecézy. Analýza obsahu potvrdila niektoré v literatúre publikované názory na tému vysviacky poľských duchovných v neskorom stredoveku. V dôsledku toho boli vykonané opravy a doplnenia predchádzajúcich zistení týkajúce sa stredovekého kalendára vysviacok klerikov a ich geografického rozšírenia v bývalej hniezdenkej arcidiecéze. Výsledkom sú nové interpretácie prosopografického výskumu poľských duchovných v 15. – 16. storočí.

The origins and professional success of some representatives of the diocesan and monastic clergy are among the most important and dynamically developing areas of research into Polish clergy. An analysis of the contents of individual „ordination ledgers” and lists of ordained priests, entered in the files on episcopal actions or other church books, has played an important role in this research. These materials, preserved in abundance for some West European countries<sup>2</sup>, are much less frequent in Poland. Only one independent ‚ordination book’ from before the reforms following the Council of Trent has so far been identified in Poland<sup>3</sup>, accompanied by some registers of clergy ordained by ordinary or suffragan bishops, entered in their acts or the consistory books of the respective dioceses. In recent years, their contents have been made available to scholars in the form of source editions or extracts from sources with information on ordained clergy<sup>4</sup>.

The scarcity of materials that would shed light on priestly ordination in the Middle Ages is also reflected in the records on the clergy in the Gniezno Archdiocese. While the Gniezno archive holds several volumes of medieval records of the actions of the local archbishops<sup>5</sup>, the records of the ordained priests are available only in the book of Archbishop Zbigniew Oleśnicki<sup>6</sup>. Much shorter lists of priests ordained by the Archbishops of Gniezno in the 1560s have also survived, together with a list of candidates admitted to ordination at Gniezno Cathedral on Holy Saturday (29 III) 1404, included in the formula book of Mikołaj Kicki, scribe of the archbishop's consistory<sup>7</sup>. Studies of priestly ordination in Gniezno in the post-Tridentine period look much more promising with a whole series of ordination books that have survived to our times, kept from the second half of the 16<sup>th</sup> century by the local suffragans<sup>8</sup>. Unlike the medieval registers, however, the later ordination books from Gniezno have rarely been studied by historians<sup>9</sup>. It also seems that the large number and volume render a comprehensive identification of their content impossible for individual researchers. Moreover, the advancement of research on these materials is clearly at odds with the progress made in recent years in the study of the ordination books from other Polish dioceses, especially Krakow and Wrocław<sup>10</sup>.

In addition to the ordination books and lists of ordained priests in the episcopal records, in research into ordination in the medieval Polish dioceses of use have also been minor works which – in contrast to the mass registers of the ordained clergy – refer to individuals. I mean dispensations issued to priests ordained under special conditions (for example, age below the requirements of canon law, illegitimate origin, physical handicap), or attempts at legalizing ordinations violating canon law<sup>11</sup>, the so-called ‘dimissorial letters’ (written testimonials of diocese ordinaries that individuals have been ordained there or outside the diocese)<sup>12</sup>, requests to bishops from their guarantors (individuals or communities, for example town councils or monasteries) for the ordination of specific individuals<sup>13</sup> as well as – of particular interest to me at this point – ordination testimonies (*litterae formatae*), issued by the bishops at the request of the clergy concerned.

The study of ordination testimonies has a long tradition. The materials collected in the Vatican Archives are of special interest to historians as they include a series of a dozen or so books of testimonies of clerics who received the lower and higher *ordines* during their stay in the Holy See in the 15<sup>th</sup> and 16<sup>th</sup> centuries<sup>14</sup>. Some of the notes contained therein have been printed; based on this material, research has also been carried out into „ordination tourism” as Ludwig Schmugge put it<sup>15</sup>. Polish historians have also been interested in the Roman books

of „formats”; based on their contents, Marek Kowalski has compiled a list of priests from Poland ordained in the Holy See in the 15<sup>th</sup> and early 16<sup>th</sup> centuries<sup>16</sup>. Stanisław Jujeczka used them in compiling a list of clerics from Poland, Lithuania and Prussia, ordained in Rome in the 16<sup>th</sup>-20<sup>th</sup> centuries<sup>17</sup>.

Unfortunately, no independent *libri formatarum* have survived in Polish archives. Researchers into the medieval ordination testimonies of Polish clergy have at their disposal source materials much more modest, and more scattered than the Roman documents. They form a small body of originals containing „formats”, as well as their copies entered in the files of episcopal activities or in the consistory books of individual dioceses. The first person to take interest in the issue was August Kolberg, who in 1880 published excerpts of selected documents from the so-called ‚Uppsala Formula’, which included testimonies of ordination of clergy from the dioceses of Chełm, Warmia, Sambia and Pomezania<sup>18</sup>. In the following years, priest Jan Fijałek searched the „formats” of the Polish clergy. However, he did not publish the results of his research in print<sup>19</sup>. Some such monuments from the diocese of Wrocław were also made available by Bishop Wincenty Urban and Stanisław Jujeczka<sup>20</sup>. In recent years, individual *litterae formatae* of clergy from the dioceses of Kraków, Płock, Poznań and Włocławek have been mentioned in literature on the subject<sup>21</sup>.

Researchers into the late medieval Gniezno archdiocese have come across similar accounts. In the late 19<sup>th</sup> century, testimonies of ordination were published for Mikołaj (son of Borzysław) from Starzyny, who in 1435 was ordained subdeacon and presbyter in Horodok and Lviv by Janusz of Lubień (Bishop of Przemyśl) and Jan Rzeszowski (Archbishop of Lviv)<sup>22</sup>. In the early 20<sup>th</sup> century, Franciszek Piekosiński published a document issued in 1440 by Jan, suffragan of Gniezno, containing a testimony of ordination of a certain Paweł *de Czelany*<sup>23</sup>. To a limited extent, the testimonies of the ordination of Gniezno clergy were also used by Rev. Jan Korytkowski in his work on the Gniezno archbishops, Rev. Józef Nowacki in „The History of the Poznań Archdiocese „, Tadeusz Olek in a source study devoted to the activity book of Archbishop Zbigniew Oleśnicki, and Zofia Wilk-Woś in her dissertation on the late medieval chancellery of the Gniezno archbishops<sup>24</sup>. These materials were also consulted by A. Gąsiorowski, who published several „formats“ of clergymen from the Archdiocese of Gniezno as an appendix to his work on the ordination of clergy in the Diocese of Kuyavia. I also used them when analysing ordination of bishops from Gniezno in the late the 15<sup>th</sup> and the early 16<sup>th</sup> centuries<sup>25</sup>. A search carried out in the medieval episcopal and consistory records of medieval bishoprics in Poland has shown, however, that these books contain more clergy „formats“ from the Gniezno archdiocese than literature on the subject suggests.

The edition and analysis of their contents resulted from a conviction that they are of great importance for research into ordination, the itineraries of the archbishops of Gniezno and their suffragan bishops, and the prosopography of the Polish clergy in the late Middle Ages.

The research into medieval „formats“ of the clergy in the Archdiocese of Gniezno included the oldest records of the actions of the Archbishops of Gniezno<sup>26</sup>, the books of the local consistory, dating from the 15<sup>th</sup> and first half of the 16<sup>th</sup> cen-

turies<sup>27</sup> as well as the records of the foral consistories operating within the archdiocese in Kalisz, Uniejów and Wieluń<sup>28</sup>. As historians are familiar with clergy's migrations between dioceses and consecration by different bishops, research has also been carried out into the materials in the bishop's records and the consistory books of the Diocese of Krakow<sup>29</sup>, Płock<sup>30</sup>, Poznań<sup>31</sup> and Włocławek<sup>32</sup>, coupled with the records of the Lublin consistory<sup>33</sup>. These studies resulted in identifying ordination testimonies of 29 clergymen from the archdiocese of Gniezno from 1411 – 1541<sup>34</sup>. The ordinands recorded therein, the dates and places of the ordination ceremonies, their ranks and the bishops who conferred them were as follows:

A. Gąsiorowski, who researched several 15<sup>th</sup>-century clerical ,formats' from the archdiocese of Gniezno, noted that few original medieval documents containing such testimonies have survived to our times. A vast majority of them are preserved in the form of copies inscribed in various formula books or acts of episcopal action. Another conclusion was that medieval ,formats' are highly standardised and bereft of individual features that would indicate, say, the motives of the ordained clerics, or the reasons why their patrons gave them the sureties necessary to achieve *ordines maiores*<sup>64</sup>. The material summarised in the table above confirms these observations. Except for the testimony about Świętosław from Parczewo, signed by Andrzej, suffragan of Gniezno, the others have survived as copies of original documents entered in the bishop's records or in the consistory books of the respective dioceses. The discovered testimonies were also drawn up according to a very similar formula. Most of them were given headings that clearly reflect the content of the notes they contain (*Formata Andree, clerici de Pobiedzyska; Formata Alberti de Ruchoczino; Formata Laurencii de Słupcza; Formata Laurencii de Powydz; Formata Benedicti Isdbienski; Formata Andree de Poslugowo*). Each testimony provides information about the ordained priests, the degree (in one case several degrees), the ordination received, the ordination minister, the day and place, and the church where the ceremony took place. These are followed by a dating formula and a message that the testimony was authenticated by affixing the bishop's seal<sup>65</sup>. They rarely went beyond this pattern; several testimonies record the fact of having been granted during a vacancy in the archbishopric in Gniezno with the consent of its provisional administrator (Andrzej from Pobiedziska, Stefan from Rychwał and Wawrzyniec from Słupca), or outside the archdiocese of Gniezno (Benedykt from Izdebno and Sebastian Plecki). In three cases, in addition to the usual citation of the names of the ordained priests, their patronymics and places of origin and additional information concerning the ordinands was recorded: in the 'formats' of Jan from Pobiedziska and Jan from Klecko, emphasis was placed on the fact that at the time of the acolytes' ordination, they were students of the school in Gniezno, while in the case of Marcin from Wieluń, his university and degree of bachelor of „arts“ were recorded. In one testimony (Jan from Prusinowice), the patron who presented the clergyman for higher ordination was also mentioned by name.

The dates of the ceremonies, noted in the ,formats', typically (but not always) corresponded to the so-called canonical dates of ordination. According to Church law, priests were to be ordained on the four Saturdays of the so-called quarterly ,dry days', and on a Saturday called *Sicientes* (the eve of *Iudica* Sunday), and on Holy Saturday. This rule was observed especially for higher ordinations (subdeacons, deacons, and presbyters), while *ordines minores* could be received at other times (also on Sundays), although the recommendation was against large-scale

ceremonies<sup>66</sup>. Research into priestly ordinations in the local dioceses, based on registers of ordained clergy extracted from episcopal records, has shown a marked accumulation of these ceremonies during the Lent (*Intret* and *Sicientes* Saturdays and Holy Saturday). It was advantageous for the priests who fulfilled the conditions imposed on future presbyters – the perspective of becoming sub-deacons, deacons, and presbyters barely a few weeks apart was supposed to significantly shorten and facilitate the path leading to the priestly state<sup>67</sup>. The dates of ordinations in the Archdiocese of Gniezno, known from the registers entered in 1482-1493 in the book of Archbishop Zbigniew Oleśnicki, mention only ceremonies celebrated on 6 canonical days, with a clear predominance during Lent. However, while during those 12 years the archbishop had 72 canonical terms of ordination at his disposal, the censuses mentioned only 31 such ceremonies.

At the same time, not a single year is known in which Oleśnicki used all canonical terms for the ordination of clergy. Most often – 4 times each – priests were ordained during his pontificate in 1484, 1489 and 1491. There were also cases of the hierarch ordaining clergy less frequently: in 1483, 1487 and 1488, he organised 2 celebrations each, while in 1485, 1486 and 1493 – only 1. Of the 31 ceremonies recorded in his book, as many as 25 took place on *Intret* and *Sicientes* Saturdays and on Holy Saturday, the other 6 on *Caritas* Saturdays (3 cases), *Venite adoremus* (2) and *Veni et ostende* (1). It would imply that at the time indicated above, approximately 80% of all ordination ceremonies in the Archdiocese of Gniezno took place during Lent<sup>68</sup>.

Let me juxtapose these findings with the information on ordination dates from the ‘formats’. The testimonies collated in the table above indicate a total of 29 clergymen ordained on 31 dates (Mikołaj from Drzewica was ordained three times). These ceremonies took place on the following days:

Of the 31 ordination ceremonies recorded in the testimonies, as many as 25 were held on canonical dates, while the other six were held on Sundays. The practice of conferring lower orders on Sundays is also well attested in the dioceses of Krakow, Płock and Włocławek, where bishops ordained small groups of acolytes on that very day.<sup>69</sup> Bearing this in mind, the statement prevailing in literature on the subject that the bishops of Gniezno did not ordain outside the canonical terms must be corrected<sup>70</sup> because, regarding the *ordines minores*, it is not true. Of the 25 ceremonies organised on canonical dates, 15 (60%) took place in the pre-Easter time, while the remaining 10 (40%) were celebrated on Caritas Saturdays, *Venite adoremus* and *Veni et ostende*. Notably, the testimonies issued for ordinations celebrated on the last three Saturdays mention acolytes ordained on those days. However, they also say that the bishops conferred all higher orders on those days. Therefore, the 'formats' confirm the thesis promoted in literature on the subject that a majority of candidates for holy orders from the Archdiocese of Gniezno stood for ordination during Lent. However, this opinion was based on an analysis of the lists of priests ordained by the local archbishops, while the testimonies cited above refer mainly to candidates ordained by their suffragan bishops. Of the existing testimonies, as many as 23 (almost 80%) were issued by auxiliary bishops – evidence that they were highly involved in the ordination of clergy. As the lists of candidates ordained by suffragan bishops were not always entered in the bishop's records, and no separate documentation of their activity survived from the Middle Ages, we may assume that there are huge gaps in the records of clergy from Poland, ordained in the 15th and the first half of the 16th centuries. Moreover, the above testimonies seem to suggest that the number of ordination ceremonies held on dates regarded as less popular was slightly higher than expected.

Of the 29 clergymen recorded in the testimonies, the vast majority were ordained in the Gniezno archdiocese. The only exceptions to this rule were:

Benedykt from Izdebno and Szymon from Gutowo, who became acolytes in the cathedral in Poznań, and Stanisław Plecki, a parish priest from Orłowo, who received ordination to the subdeaconate in the Krakow cathedral. The list of places within the Gniezno archdiocese, where the ceremonies took place, is as follows:

Following previous research on the ordination of clergy, based on lists of priests entered in Zbigniew Olesnicki's book, an argument was put forward that in the Gniezno archdiocese, ordination ceremonies were organised mainly in the archbishop's favourite residences in Łowicz and Skierniewice, much less frequently in Gniezno<sup>71</sup>. On the other hand, the information contained in the 'formats' shows that the Gniezno cathedral (occasionally also the Gniezno Franciscan church) prevailed as venues of the ceremonies. Perhaps it was primarily the resident suffragan bishops who ordained in the archdiocesan capital, while the ordained bishops convened the candidates in the locations of their residence, except during Easter.

Most of the medieval ordination testimonies published to date mention the conferring of the acolyte ordination on the clerics. Given the custom of accumulating lower ordinations it was no doubt tantamount to these individuals receiving all the other *quatuor minores*. Information about the recipient's acceptance of the subdeaconate, diaconate or priestly ordination is less frequent in the materials; unlike testimonies issued in the 15<sup>th</sup> and early 16<sup>th</sup> centuries by officials of the Apostolic Camera, the native 'formats' do not include candidates to the clerical state accepting tonsure. The testimonies analysed here also follow this rule: of the 31 degrees of ordination documented in the 'formats', as many as 26 concern acolytes. Only three clergymen fell out of this pattern: the testimonies of Jan from Prusinowice and Stanisław Plecki report on their ordination to the subdeaconate. The testimony of Mikołaj from Drzewica is atypical as it reports all three higher ordinations taking place between 26 February and 1 April 1458. Aggregate testimonies (covering several degrees of ordination) are admittedly well attested in the case of clerics who received their ordines in Rome. However,

of the local materials introduced into scholarly circulation, only the ‘formats’ issued by Bishop of Chełm, Maciej from Stara Łomża for Stanisław from Kowal in the Diocese of Włocławek bear similarity to the testimony issued for the benefit of Mikołaj. In the spring of 1498, a few weeks apart (Saturdays: *Intret, Sicientes* and Holy Saturday), Stanisław from Kowal received all the higher ordinations from this hierarch.<sup>72</sup> Another proof is the testimony of Jan from Strzyżów in the diocese of Krakow who received all the *ordines maiores* between 27 February 1490 and 2 April 1491 from the hierarch in question<sup>73</sup>.

In a few cases, it is possible to reconstruct the education of the ordained clergy. For certain, 2 of them (Jan from Pobiedziska and Jan from Klecko) studied at the cathedral school in Gniezno when taking their lower orders, while 9 or 10 others had university studies documented in their curricula vitae. Marcin from Wieluń began his studies in Krakow in the summer term of 1484, and after a few years (1487) was promoted to bachelor of „arts“ there, and then (1492) attained the degree of Master of Arts<sup>74</sup>. Given that Marcin entered the lower orders in 1491, we can assume that he only decided on a clerical career towards the end of his tertiary studies. A similar path was probably followed by Mikołaj from Drzewica, although, as the testimony does not give his father’s name, some caution must be exercised in identifying this cleric. Nonetheless, it is probably possible to identify the Mikołaj from Drzewica mentioned in the 1458 testimony with Mikołaj from Drzewica (son of Jakub), who enrolled at Krakow in the summer term of 1450<sup>75</sup>. If this suggestion is accurate, we consequently need to assume that Mikołaj did not stand for higher ordination until several years after leaving the university. Possibly, he delayed ordination for so long because he lacked the proper title necessary to attain *ordines maiores*, and it was only after becoming an altarist in the Poznań parish church that he stood for ordination as subdeacon, deacon, and priest, within a few weeks. Prior to his lower ordination, Benedykt from Izdebno also studied in Krakow, starting in the summer term of 1505<sup>76</sup> while he stood for ordination as an acolyte four years later, in April 1509. Jan from Widawa, who began his studies in the winter term of 1504, followed suit<sup>77</sup>, while he took the lower orders after another 6 years, in March 1510. The course of Jan from Sarnowo university education was somewhat different: unlike the above-mentioned priests, he entered the Krakow register in the summer term of 1483, probably immediately after taking holy orders as an acolyte<sup>78</sup>. The same path was taken by Andrzej from Nadborowo who joined the University of Krakow in the summer term of

1510<sup>79</sup>. It was only 10 years after his lower ordination (1439) that Piotr ze Žnina came to Krakow to study, and he entered the university metrics in the winter term of 1449<sup>80</sup>. However, it is difficult to say at what stage of his life Stanisław Plecki was a student. We know that he began his studies in Krakow in the summer term of 1535<sup>81</sup>. However, as the exact time of his *ordines minores* remains unknown, it is not possible to establish whether he had already embarked on a clerical career before the date specified above or only after leaving the university. It is not unlikely, however, that Stanisław entered the Krakow clergy during his studies – the practice of students taking holy orders has been attested to in many university towns<sup>82</sup>. Wawrzyniec from Powidz, whose name is mentioned in the 16<sup>th</sup> century sources as a doctor of decrees, could also be proud of his thorough intellectual formation<sup>83</sup>. The exact course of his studies is unknown; as his name is not included in the Krakow university records, he must have completed his legal studies outside Poland, perhaps at a university in Italy. The issue of the higher studies of Maciej from Bądkowo, son of Jan, remains unclear. The „Metrics“ of the Krakow Faculty of Arts do not mention this person, while the local „Book of Promotions“ presents under 1489 Maciej from Bądkowo, a Bachelor of Arts, whose patronymic is not mentioned<sup>84</sup>. While the temptation to identify them is natural, an important doubt arises as his education is not mentioned in the ordination testimony of Maciej from Bądkowo, and the example of Marcin from Wieluń shows that this information was recorded in the ‘formats’. In fact, Maciej from Bądkowo, a Bachelor of Arts, was hypothetically identified by the publishers of the Krakow university records with Maciej *de Bandow*, son of Wawrzyniec, entered in the students’ metric in the summer term of 1477<sup>85</sup>. If we agree with this proposal we need to accept that as many as 12 years elapsed between Maciej’s matriculation and his bachelor’s promotion, a suspiciously long period, since the vast majority of Krakow’s bachelors of arts achieved the degree between 1 and 3 years after joining the university<sup>86</sup>. We do know, however, that a small part of Krakow’s students was first promoted 10 or more years after starting their studies<sup>87</sup> so, in theory, identification of the persons in question is possible.

Of the clergymen mentioned in the testimonies, Benedykt from Izdebnia undoubtedly enjoyed the greatest career in the Church structures. Ordained an acolyte in 1509, in the following years he was notary of the Gniezno consistory, canon of Gniezno, Krakow and Poznań, bishop of Kamieniec, and finally (in 1546 -1553) bishop of Poznań<sup>88</sup>. Apart from him, the following individuals also progressed in ecclesiastical careers: Wawrzyniec from Powidz, who in 1513 came into possession of a canonry in Kalisz, and then was a member of a milieu of the collegiate church of Łowicz, becoming archdeacon and judicial vicar<sup>89</sup>; Jan from Sarnowo and Wojciech Oblaczkowski, perpetual vicars at Gniezno Cathedral<sup>90</sup>, as well as Andrzej from Nadborowo, a canon in the Poznań chapter<sup>91</sup>. The sources from the early 16th century mention two individuals named Wawrzyniec from Słupca. One of them was a vicar in Kowalewo and the other an altarpiece in Słupca. One of them may be identified with an acolyte ordained on 2 March 1493 but – if we assume that this is the altarpiece from Słupca – we would have to assume that at some unknown time, this clergyman stood for all higher orders, including the presbyterate<sup>92</sup>. Several other ordinands acted as public notaries: Wojciech from Ruchocin, who became an acolyte in September 1437, is mentioned as a notary in 1446<sup>93</sup>; Jan from Klecko, ordained as an acolyte in December 1470, was mentioned as a notary in 1487<sup>94</sup>; Jan from Sarnowo, who took his lower ordination in June 1482, was attested as a notary in 1489<sup>95</sup>; Marcin from Wieluń, ordained as an acolyte in May 1491, was a notary in 1489<sup>96</sup>, while Wawrzyniec from Powidz, ordained as an acolyte in May 1499, in the same year began to act as a public notary and in this role he worked alongside Archbishop Jan Łaski<sup>97</sup>.

Considering the fact that very little material has survived from the time before the reforms of the Council of Trent, illustrating the ordination of clergy in Poland, the medieval *litterae formatae* must be considered important sources for research into the prosopography of the clergy, the internal structures of individual dioceses, the benefice system, canon law and, most obviously, the practice of ordaining clergy.

In this situation, making an inventory of all these materials and making them available for research are important research propositions.
